TERMS AND CONDITIONS

LPEBL – STEWART INTERNATIONAL SCHOOL VISHENKA Russian-English NURSERY

Any parent who has filled in and submitted the School Place form is presumed to have read and accepted the Terms & Conditions notified below. The acceptance letter, the Terms & Conditions and its annexes (the Financial Policy and the School Rules and policies available on the school's website) are the basis of the legal "contract" between La Petite Ecole Bilingue London (LPEBL) - Stewart International School and the Parents.

INTRODUCTION – The parties

- → "La Petite Ecole Bilingue "VISHENKA", private independent bilingual nursery registered by DFE under the number EY332671, named "LPEBL" or "The School"
- → Parents/responsible persons who have signed the acceptance letter (cf. article 1), named "the Parents".

ARTICLE 1 - PARENTAL AUTHORITY

If the Parents declare that they have sole legal parental authority, both should submit the School Place Offer form.

The Parent/legal responsible adult who has submitted the School Place Offer form declares that he/she has sole legal parental authority under a court order. (A copy of the court order must be provided.)

The School expects the Parents or responsible persons to communicate with each other and to agree about their child's education. The School will be entitled to accept instructions from either parent without reference to the other. Special dispositions can be put in place in the case of parents who are separated according to any court order provided.

ARTICLE 2 - The SCHOOL RULES and POLICIES

Parents undertake to read and sign the Nursery rules provided at the beginning of the school year.

Compulsory school Policies are available on the school's website





The School rules and Policies may be updated during the school year; in this case the updated versions are available on the school's website.

We consider that every member of the School should feel valued and respected, and that each person should be treated fairly and well. Bullying, harassment, victimisation, intimidation and discrimination will not be tolerated. The School's anti bullying policy forms part of these Terms and Conditions. The School applies the Equality Act 2010 and expects the same of the School community.

<u>ARTICLE 3 - PROVISION OF EDUCATION</u>

The School undertakes to educate the child during the school year, excluding the school holiday periods, as specified in the school calendar published at the beginning of each school year. It is the Parents' responsibility to accompany their child to school and also to collect him/her.

ARTICLE 4 – APPLICATION PROCESS

4-1 FIRST APPLICATION

Stage 1: Pre-application

A)Families are required to return the completed and signed pre-application form: this form is available on the school's website or upon request by email at clubs@lpebl.com, vishenkanursery@gmail.com, admin@stewartbilingualschool.com.

Parents are expected to fill in and send back the pre-application form prior to their visit in order for their visit to be arranged and their child to be enrolled on our waiting lists.

B) Make an appointment

C) Admission commission

Place offer criteria and priorities:

- Children with a sibling already attending one of our schools, are offered places in priority
- among the pre-applied children, the school will consider first the older children within each age range
- the capacity to speak one or the other language





- for children under 3yoand who may not speak even their mother tongue, will be assessed their level of independence and autonomy

Stage 2: Place offer

Enrolment campaign schedules vary according to the child's age of entry. The offer of a place requires the previous pre-application by Parents of the child, and abides by the criteria detailed in our Admission Policy (available on the school's website). The offer consists of an online School Place Offer form and an Application Form and is exclusively made by email. Parents are thus requested to return these two documents duly completed and signed by email within the given deadline. The offer of a place is only valid for ten days.

Stage 3: Registration

The application is final when the formalities detailed below have been completed (in due time):

Administrative formalities

- The School Place Offer form has to be completed, signed and returned (parents are required to read the Terms and Conditions attached to the place offer email)
- Application form has to be completed, signed and returned by email and a printout to the school office
- Medical form, authorisation to collect form and photo consent form need to be completed and returned by email and as a printout to the school office
- Copies of both Parents/ legal responsible adults' passports have to be sent.
- Copy of the child's passport has to be sent
- In the case of a divorce/ separation: copy of the court order settling the custody arrangements has to be provided; a letter co-signed by both parents and detailing their common custody arrangement is required if no court order has been taken

Financial formalities

- o Payment of £160 registration fee
- Payment of £600 advance for the 1st term a child starting the school
- Payment of £600 deposit for the last term (In order to terminate the contract and leave the school parents need to give 1 term notice, otherwise, £600 deposit won't be refunded).

Leaving Date end of Autumn Term: Notice must be given prior to 1st week of Summer Term

Leaving Date end of Spring Term: Notice must be given prior to 1st week of Autumn Term

Leaving Date end of Summer Term: Notice must be given prior to 1st week of Spring Term).

NB: these payments are not refundable even though Parents may cancel the application at any time during the process. .Whatever the motive for cancellation, paid fees are not transferable for a later intake. After a cancellation, parents wishing to re-apply at a later date, will have to start the whole administrative and financial process again.

Parents' consent to the school making enquiries of the pupil's previous schools for confirmation that all sums due and owing to such schools have been paid. Parents also consent to *Vishenka-LPEBL* informing any other school to which the pupil is to be transferred if any fees of *Vishenka-LPEBL* are unpaid. A School registration termination certificate will be issued only if all fees due have been paid. In addition, parents' consent to provide the school with their child school report of the previous school before the intake of their child.

4-2 RE-ENROLMENT

A) Process

The child's re-enrolment in our school for the following school year is valid when Parents have followed the two steps below in due time:

- Notification of the child's Re-enrolment by email. Parents have filled and submitted the online Re-enrolment form. (Parents are required to read the Terms and Conditions attached)
- Payment of £600 advance for the 1st term a child starting the school.
- Payment of £600 deposit for the last term

NB: if parents fail to complete one or the other step, the child is automatically withdrawn from the school's register. The £600 advance is not refundable even if Parents may later choose to withdraw their child.

B) Conditions of admission

In order to be offered a place for their child in our school:

o Parents have to complete the whole pre-application and application process in full and in due time. Any missing document or payment will incur a cancellation of the application in our files.





o Pupils are enrolled based on their year of birth. (NB: Child has to be two full years old on the 1st day of his/her intake. Younger children may be also enrolled (subject to certain conditions)).

o Vishenka/LPEBL will offer a school place depending on the availability in the group on the date of the child's intake.

o Priority will be given to a child who already has a sibling registered in our school.

o In the case of multiple applications in a year group, priority will be given to the older child.

o When applying for a child with Special Needs (whether the needs are regarding learning, physical abilities or health issues), parents need to confer directly to the Head Teacher who will determine the frame which Vishenka/LPEBL is able to set up to welcome the child and ensure her/his progress and safety. The School Place offer is then conditioned by the agreement of both parties on the proposed frame.

o As detailed in the Terms & Conditions: Any withholding or misrepresentation of information or facts about the family or the child is considered as a breach of contract which LPEBL will terminate consequently keeping any paid sum.

ARTICLE 5 - 1st ENROLMENT FEES

The registration fee of £160 and £600 advance for the 1st term a child starting the school. These payments are not refundable if the Parents later decide to withdraw their child whatever the reason for cancellation. £600 deposit for the last term. If contract is terminated in the middle of the term £600 deposit stays in the school. In order to terminate the contract 1 term notice is required.

ARTICLE 6 - SCHOOL FEES

For financial purpose, the school year is divided into three periods called terms, detailed as follows: September/October/November/December – Term 1; January, February, March/April – Term 2; April, May, June, July – Term 3.

Fees are payable at the first week of the beginning of each term as stated in the calendar. The school reserves the right to refuse to admit a child if fees have not been paid, even in the middle of the school year.

Parents are made aware of school fees for the next year during the second term. There is no school on Wednesday afternoons. We offer Wednesday club which is not included in school fees.





There is a 10% discount from the second child. This discount is applied to school fees only and is not to be applied to any other fees such after-school care.

Fees for any started term will not be refunded and remain retained by the school.

In the case of a legal decision to change school, the fee for the term currently in process remains due to the school.

Tuition fees will be payable in full for intakes occurring within the 1st period of each term (cf. school calendar available on the school's website). For intakes occurring after the 1st period, tuition fees are calculated prorata the attendance of the child

Barring serious motives or circumstances beyond control, *Vishenka*/LPEBL undertakes to honour its commitment with regard to a child's schooling whenever the Parents have correctly regularized the fees, with the exception of a legal decision ordering schooling into a different establishment.

The Financial Policy is fully part of the Terms & Conditions and sets out all the financial dispositions Parents' consent to.

ARTICLE 7 – ATTENDANCE

Parents have to seek *Vishenka*/LPEBL's consent in writing for any planned absence: *Vishenka* manager or LPEBL Headteacher will grant the authorisation for absence or not. If a child is away for more than two weeks a 50% of the fee deposit is payable to keep the place.

No leave of absence will be granted when Parents take their child on holiday in term time. Fees for a term will not be refunded where the child is absent due to sickness or for any other reasons.

ARTICLE 8 - TERMINATION

Parents have the right to terminate the current contract by sending a registered letter with signed proof of delivery, to arrive at the school **ninety days before the start of the following term.** When failing to respect the cancellation notice, the next term remains payable to *Vishenka*/LPEBL.

Parents may terminate this contract with effect from the next school year by not reregistering. *Vishenka*/LPEBL has to be informed of the contact details of the next school the child will attend.

If Parents withdraw their child during the course of a term, *Vishenka/*LPEBL has to be notified in writing, giving details of the next school the child will attend. The school will invoice the fees for the whole term.





Vishenka/LPEBL may terminate the contract at any time by notice in writing without any obligation to return any fees or deposit paid by parents in the case the pupil or the Parents find themselves in breach of the Terms & Conditions and/or any of the School Rules. Any withholding or misrepresentation of information or facts about the family or the child is considered as a breach of contract which Vishenka/LPEBL will terminate consequently keeping any paid sum.

ARTICLE 9 - ACTIVITIES DURING THE HOLIDAYS

Aware of the particular difficulties linked to nursery and school holidays and organization of same, the nursery and school may prepare organized activities during all school holidays, for which a specific convention is formed with Parents. It is understood that corresponding fees are payable in totality, also in advance, and are due to *Vishenka* nursery or LPBEL, including ulterior renunciation from Parents. However, these fees are totally reimbursed if the education/activities are not performed due to reasons enumerated by *Vishenka* nursery or LPBEL.



- Forget about politeness: do not hold the gate open for a parent if the other one is open!

Late

- If you are late to collect your child at 12:00, please let us know.
- If we do not hear from you we will bring your child to the Main School.
- Please, let us know in writing of any changes regarding the collection of your child
- In emergency and if nobody known by us can come, please give a letter to the person collecting your child.

Sickness

• Please, if your child is sick; let us know early so that we can reassure the other parent

Cleanliness

Please bring your child clean in the morning (nappy)

• If he/she has "an accident" in the car, please feel free to use the facilities and change him/her yourself, as we are all busy welcoming children and parents in the morning





• Likewise, at 12.00, when you collect your child, if he/she has an accident at 5 minutes to 12.00, please ask one of the team to change him/her.

Potty training

When your child is just beginning to be potty trained, we want you to:

- Accompany him/her to the toilet when you arrive in the morning
- We will bring him/her to the toilet before snack, after snack, before he/she goes home
- We will not ask him/her every 10 minutes as he/she at school and not at home and must respect routine.
- If your child is ready-wearing pull ups, but prone to accidents, please give us a nappy to avoid undressing him/her completely when we change him/her.
- Please avoid bodies, belts, and dungarees. Remember the aim is to promote autonomy.
- Please remember, that even if your child is potty-trained, events like starting school, a new baby, moving to a new house..., might regress him/her temporarily.

Clothing

- The school has no uniform: we believe that dressing differently at this age will promote the children self-esteem and give opportunities to develop language.
- Please dress your child sensibly to allow him to participate fully in all activities.
- Please, mark all items of clothing, in particular, hats, scarves, gloves
- Please, bring back any clothes we give you when changing your child.

When raining, please, bring your child in boots. Going outside in all weather is important for your child.
